REVIEW MINUTES from December 18th 2018 Chamber Board Meeting. Accept minutes as presented.

DISCUSSION OF CONFLICT OF INTEREST – Mary Council

Colorado's Conflict of Interest Statute §7-128-501 as well as §§7-128-401 and 402 regarding duty of loyalty were presented regarding the conduct of directors.

TOWN OF WELLINGTON - Ed Cannon, Town Administrator

- Budgeted \$300,000 toward Economic Development.
- Finalizing job description of full time Economic Developer that will be filled March 2019.
- Reviewing Buxton Coorporation contract on Tuesday, January 15th, which is a retail strategy organization that will help generate leads and bring retail shopping and restaurants to Wellington. Esri Database software will be used to complie a collection of geographic datasets of various types and services.
- Population is currently estimated at over 11,000; \$78,000 median household income and an average of 35 years of age per household. The next census will be made 2020 and communications will be sent out from the Town Hall for an accurate count.
- (MOU) Memorandum Of Understanding between the Town, Wellington Colorado Main Streets Program and the Wellington Area Chamber Of Commerce. Date of meeting is pending.
- Water treatment plant expansion upgrades consisting of \$12 million, in September 2018, has increased to a \$23 million project.

MAIN STREETS PROGRAM – Annie Lindgren, Executive Director

- June 1st Brewfest including 16 breweries, a expanded venue and additional tickets will be offered.

railroad tracks near 1st Street and Cleveland Avenue.

- Marketing Leakage Analysis is complete and results will be reviewed with a consultant by April 2019.
- North Forty News will be featuring monthly articles written by Annie Lindgren regarding Wellington.

the Town on future economic development needs.

- Jon Slutsky appointed an Ad Hoc Committee consisting of the following members: Steve Vessey, Mary Council, Heather Zadina and Jon Slutsky to represent the Chamber in discussions with the Town of Wellington and The Main Streets Program to form a Memorandum of Understanding concerning Economic Development in Wellington.
- The Bylaws Committee will revise the existing By-Laws regarding the elimination of the approval of new memberships and notifly the membership via email.

BUSINESS SUPPORT SUB-COMMITTEE – Kristi Cannon

The Town has budgeted \$10,000 for the Chamber to offer ScaleUp Smart Classes, through the Small Business Development Center, to businesses in Wellington. Interested businesses will need to apply and be approved prior to each class. The Town will fund 80% of the cost and the business will be responsible for the remaing 20%. Kristi will also be working with the Small Business Development Center and Larimer Workforce Center to introduce leadership training courses in Wellington. Each class will cost any where from \$30-\$40 per class / per person. A suggestion was made to record the courses and have them availabe to members as needed.
